### **LEAD GROUNDSKEEPER SPECIALIST**

#### **Definition**

Under direction leads other employees in the performances of grounds maintenance and gardening tasks.

#### **Minimum Qualifications**

#### **Education & Experience**

Any combination equivalent to: Completion of twelve (12) units or the equivalent in plant science, ornamental horticulture or a related area and progressively responsible experience (3 years or more) as a Groundskeeper Specialist or as a Groundskeeper and Equipment Repair Specialist or a similar position in a large crew setting conducting grounds maintenance work.

#### Licenses:

- Class C Drivers License is required
- State of California Department of Pesticide Regulations (or DPR)-Qualified Applicator Certificate or License to apply Pesticides.

#### **Essential Job Functions**

Care for established landscaped areas by mowing, aerating, edging, grubbing, mulching, removing thatch, trimming and weeding around flower beds, walkways, and walls according scheduled needs. Plant, cultivate, prune, fertilize and irrigate flowers, trees, grass, shrubs, and other plant material in order to preserve softscape areas. Identify and conduct treatment for diseases in landscaped areas in order to prevent contamination. Prepare soil for new sod, seeding or overseeding in order to adjust to seasonal changes in accordance with planned use. Collect debris and refuse from tree trimming and removal operations into piles, using shovels, rakes or other tools in order to clear site. Care for hardscaped areas by using blowers, brooms, shovels, rakes, and other tools in order to clear sites. May perform other related duties as needed.

#### **Assessment Process**

The assessment process will include screening to ensure applications are complete and meet

all minimum qualifications. The application requires the completion of Supplemental Questions to evaluate your education, training and experience relative to the required knowledge, skills and abilities for the position. Answers should be as complete as possible, as no additional information will be accepted from applicants once the application has been submitted. Only the most qualified applicants, who pass the minimum qualifications review, will be invited to the assessment process.

The assessment process will include a competency assessment (40% weight) and an oral interview assessment (60% weight). Only the most qualified candidates will be invited to the competency and oral interview assessments. Passing score is 75% out of 100% on each testing section.
