DPR has two new fumigation categories available for Qualified Applicator License (QAL) and Qualified Applicator Certificate (QAC) holders. If you perform pest control using a pesticide labeled as a fumigant, you must obtain the new Soil Fumigation (Category L) and/or Non-Soil Fumigation category(ies).

Individuals need to obtain the required fumigant use category(ies) prior to January 1, 2024 to continue conducting fumigant pest control activities uninterrupted in 2024.
